New Payment Option Plan for Chrysalis Moon 2012

We are attempting something new this year. To help ease the burden of coming up with the full amount of registration fees all at once, we are instituting a payment option plan. If you chose this option, all rules must be adhered to with no objections.

The payment option rules:

- The full amount of all registration fees will be divided into 3 (three) equal parts.
- Each payment is to be made monthly.
- The first payment must be accompanied with all registration and signed waiver forms.
- Pay Pal **is not** an option for this payment plan.
- **Note:** Your e-mail address must be stated on the registration form. You will be reminded each month by e-mail prior to the payment due date.
- Last date to take advantage of the payment option plan is April 27, 2012.
- If final payment is not postmarked by June 27, 2012, all registration fees will be forfeit with no refund, no exceptions.

Example:

If 2 adults register on April 27, 2012, the total registration fee is one hundred and fifty dollars (\$150). Fifty dollars (\$50.00) will be sent in with a completed registration form and signed waivers.

On May 27, 2012 the second payment of fifty dollars (\$50.00) is due.

On June 27, 2012 the third payment of fifty dollars (\$50.00) is due

- ❖ Remember, no matter what month you choose to start the payment plan, the last payment is due (postmarked) no later than June 27, 2012.

This is an all-cabin camping event. Each registrant will be assigned a bunk in a cabin. There are 4 camping units (Earth, Air, Fire and Water). Each unit contains one lodge and 7 cabins of various capacities.

- 8 cabins with 2 beds
- 2 cabins with 3 beds
- 4 cabins with 4 beds
- 14 cabins with 5 beds
- 4 twelve bed lodges all with electricity (**\$5 per adult additional**). Persons with special need for electricity (e.g. uses a C-PAP machine) will be given first priority to the lodges for no additional bed fee.

*****VENDOR RULES*****

- 1) Definition: Vendors provide services or sell products. Products and services prohibited include alcohol, tobacco and anything prohibited by local, state, DNR, and federal laws.
- 2) Vendor shall provide all items needed for the booth (tables, chairs, tent, water, etc.).
- 3) Vendors must comply with all fire, health, safety and other applicable laws, rules or regulations. Examples include: Have a 2A-10BC fire extinguisher.
- 4) Vendor set-up shall be confined to the space ordered. Please be respectful of your vendor neighbor's space.
- 5) A space cannot be sub-let or given to another party without prior written permission from the Festival Committee.
- 6) Vendors shall keep their space and area surrounding it free of litter and trash at all times. All refuse must be disposed of appropriately.
- 7) This is a 5-day event with NO rain date or refunds.
- 8) Chrysalis Moon 2012 and its agents/employees/volunteers shall not be liable for any damage either to person or property, sustained by the VENDOR or by any other persons. The VENDOR further agrees that all personal property upon the premises belonging to vendor or any other person shall be at the risk of the VENDOR only and that the Chrysalis Moon 2012 and its agents/employees/volunteers not be liable for any damages thereto or theft thereof.
- 9) Chrysalis Moon reserves the right to require removal of any advertising or merchandise we consider to be offensive or that violate DNR policy.
- 10) Disregarding or ignoring any terms of this agreement are immediate grounds for suspension of VENDOR sales or privileges.
- 11) Payment for booth space constitutes your acceptance of the terms and conditions contained herein.
- 12). The CM vendor coordinator will send each pre-paid and registered vendor a DNR Vendor Permit form. This form must be filled out and returned to the vendor coordinator 3-weeks prior to the festival starting date. If this form is not received within the date stated vending privileges may be denied.
